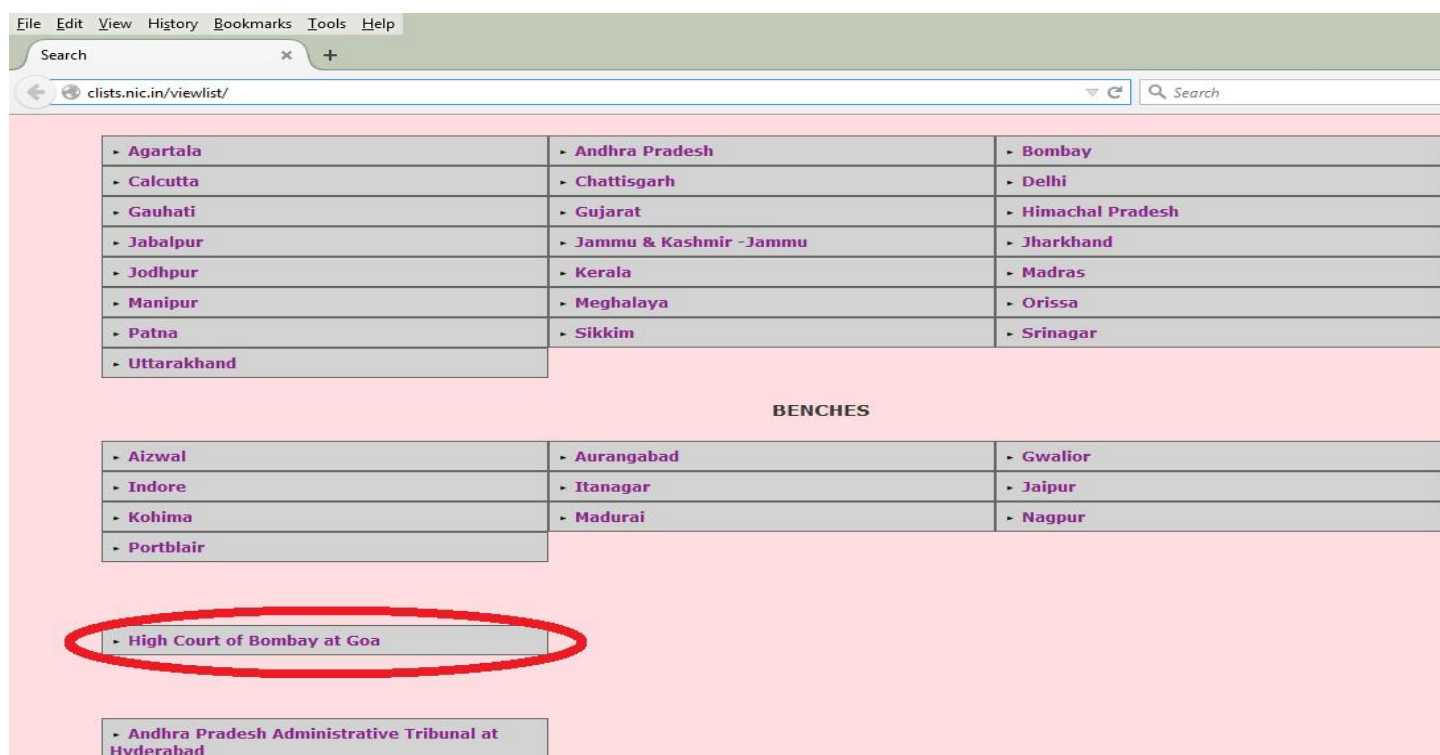

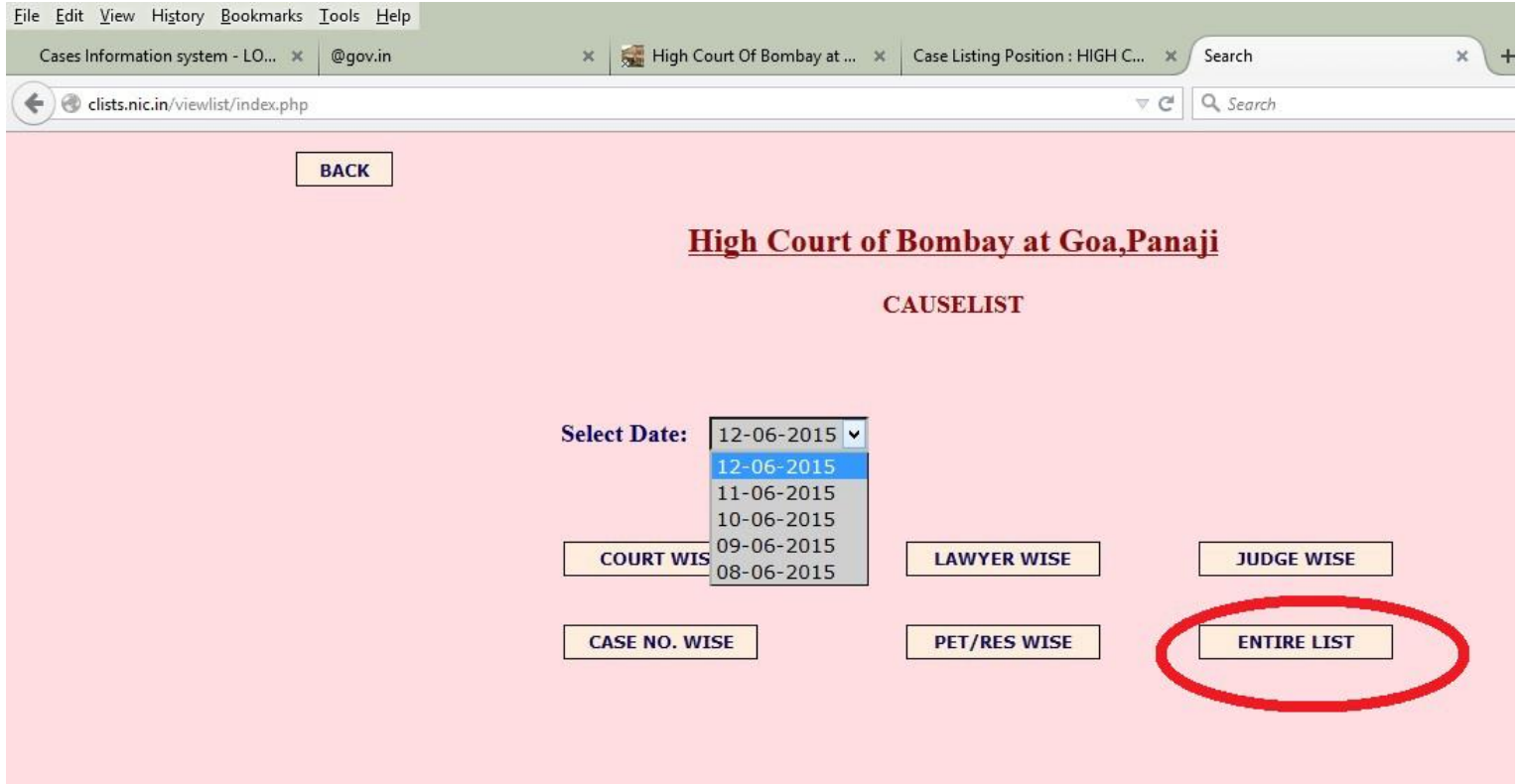
You will get six options for accessing different type of Causelist. i.e.

1. **Daily List** (to view daily Causelist i.e. **Admission/Order Causelist**)
2. **Supplementary List** (to view daily supplementary Causelist i.e. Admission/Order Causelist)
3. **Weekly List** (to view weekly Causelist i.e. **Admission/Order Causelist**)
4. **Weekly Supplementary List** (to view weekly supplementary Causelist i.e. Admission/Order Causelist)
5. **Monthly List** (to view monthly Causelist i.e. **Final Hearing Causelist**)
6. **Monthly Supplementary List** (to view monthly supplementary Causelist i.e. Final Hearing Causelist)

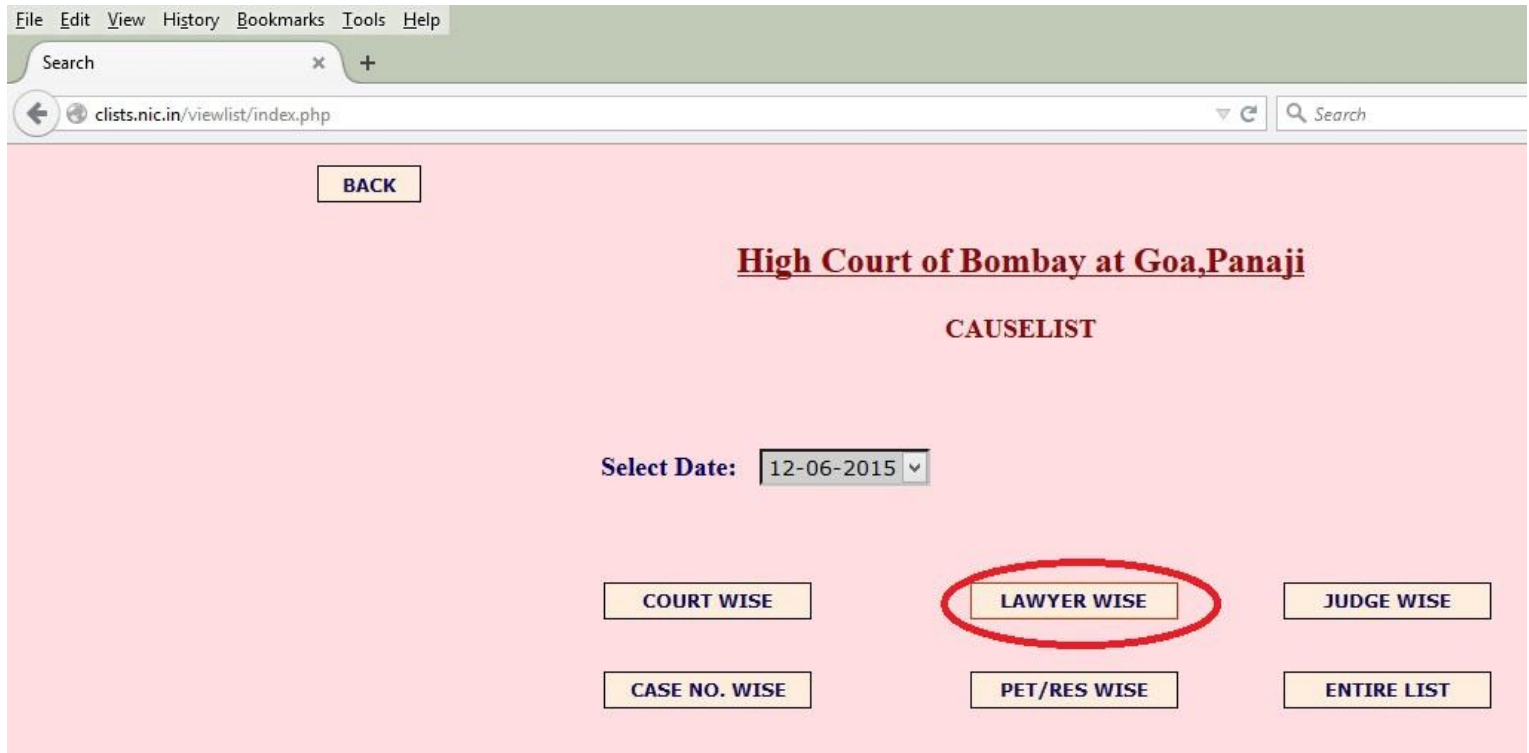

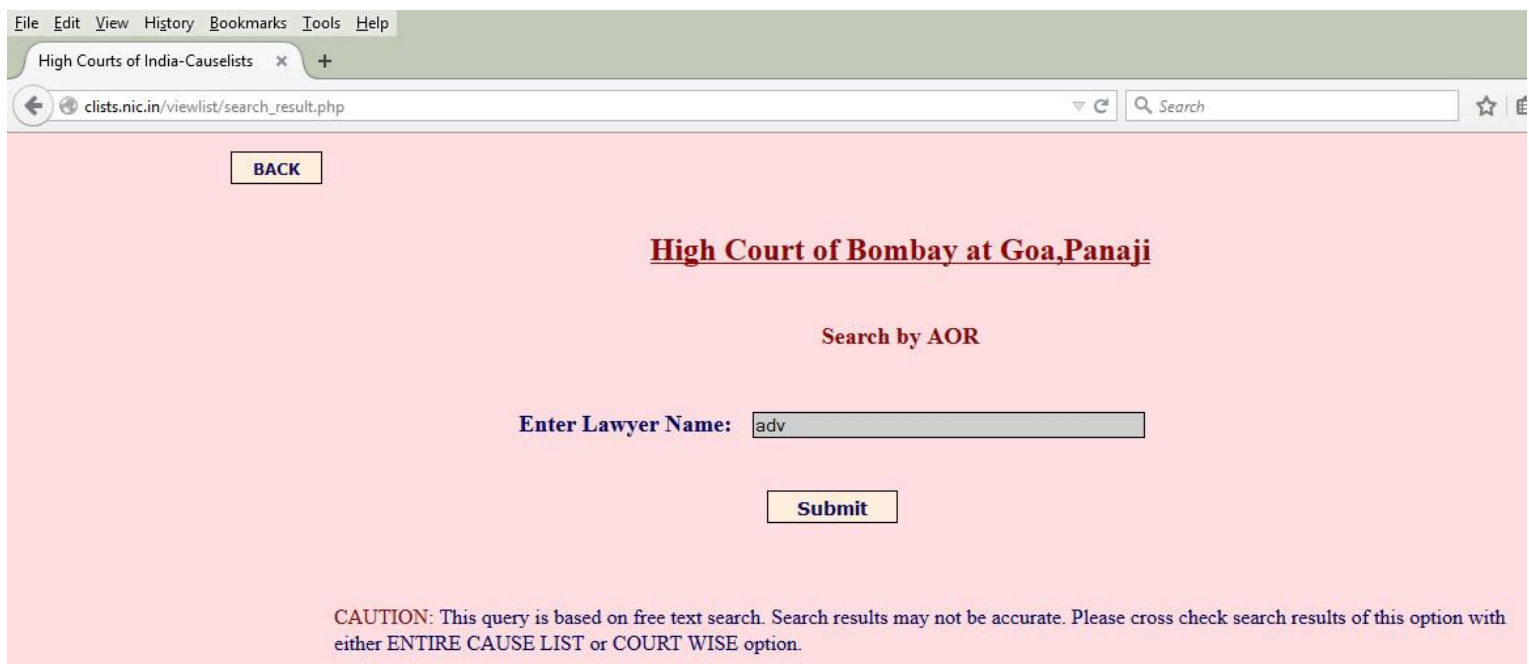
