# **AMC REQUIREMENTS**

## • **Scope of AMC (HVAC)**

### **1. Preventive Maintenance**

- Scheduled inspections (monthly, quarterly, or as agreed).
- Cleaning of filters, coils, condensers, ducts.
- Lubrication of moving parts.
- Calibration of controls, sensors, and thermostats.
- Checking refrigerant levels and topping up if necessary.
- Checking electrical connections and control panels.
- Testing system efficiency and performance.
- Duct inspection for leaks or damages.
- Indoor Unit Associated With Pipeline

### **2. Corrective/Breakdown Maintenance**

- Repair or replacement of faulty components.
- Emergency support.
- Troubleshooting operational issues.

### **3. Consumables and Spare Parts**

- All spare parts and consumables are included in the comprehensive AMC.
- Original or OEM-approved parts to be used.
- Maintaining a stock of frequently required parts.

### **4. Manpower Support**

- Deployment of **one skilled technician** for operation and maintenance of the HVAC system.
- Technician to be present on-site **daily from 9:30 A.M. to 5:30 P.M.**, excluding Sundays and holidays.
