### **GENERAL TERMS AND CONDITIONS:-**

1. The Sealed Quotations must be superscribed as **"Quotations for Comprehensive & Non-Comprehensive AMC of BioDigester Plant"** and addressed to **the Registrar (Admn.), High Court of Bombay at Goa, Penha-de-Franca, Porvorim, Goa.**
2. The quoted rate shall remain valid for one year i.e. w.e.f. **01/05/2025 to 30/04/2026.**
3. It shall have PAN number, GST Registration number.
4. The dealer should provide the name and mobile number of the person, to be contacted at any time, even beyond office hours. The person should be capable of maintaining and servicing of BioDigester Plant.

5. The dealer will provide uniforms, Aprons, Photo I-Cards and other-Protective gear to ensure proper protection to the appointed person. It will be the responsibility of the dealer to ensure that its entire staff report for duty in proper uniform and also display their identity cards.
6. The Registrar (Admn.), High Court of Bombay at Goa, Porvorim, reserves all rights to reject any offer or terminate the P.O. at any point of time, without assigning any reason.

**AMC Requirements:-**

- Operation and maintenance of BioDigester Plant.
- To keep surrounding areas clean.
- Logbook to monitor overall operation of plant on daily basis.
- Continuous or periodic performance monitoring of the biodigester system to ensure it is operating within optimal parameters (e.g., temperature, pressure, pH level, gas production, etc.).
- Inspection and maintenance of the gas collection system (e.g., gas holders, pipelines, and vents) to ensure that gas is being efficiently captured and stored.
- Monthly or quarterly inspections to check the health of the plant and its various components.
- Regular cleaning of the digester tank, pumps, pipes, and valves to prevent blockages, sediment buildup, and corrosion.
- Regular inspection of safety equipment like gas detectors, pressure relief valves, and fire protection systems to ensure they are functioning correctly.
